3. Business arising from the Minutes

4. President's Report

The President's Report was presented by Professor K.A. Smith-Miles. She supplemented her report by adding that there had been mixed views at Council when her suggestion to increase presidential terms from two to three years was discussed. The proposal will therefore not be pursued at present.

When the President reminded members of the matters in her report, the ARC issues stimulated a number of comments from members. In particular it was noted that it is vital to have more members being nominated to the College of Experts

to ensure that evaluation of mathematical science proposals is undertaken by those who are genuinely from the discipline area. In response to a suggestion that this and other issues could profitably be discussed face-to-face with the ARC, the President reported that a meeting had been held earlier this year and a further meeting would be sought.

6. Treasurer's Report and Audited Financial Statements

The Treasurer's report was presented by Dr. A. Howe. He pointed out that the Society had an operational loss of \$58,541 in the last financial year but AMPAI, which handles income and expenditure from publications, had made a profit of \$63,860, resulting in a combined profit of \$5,319. The Treasurer then further pointed out that, when student memberships are taken into account, all Divisions and Special Interest Groups had increased in size from 2016 to 2017.

7. Subscriptions and journal prices to Members for 2018

12. Decisions made by Council

The following decisions were highlighted by the President.

(a) The implementation of gender equity policies

A working party, chaired by Professor Aidan Sims has identified a variety of suggestions for the Society to improve gender equity. Council strongly supported the direction of the report and has established an Equity, Diversity and Inclusion Committee, whose Chair is to be an ex-officio member of both Council and the Nominations and Publications Committe. It was further decided that, to establish the committee membership, there should be a general call for expressions of interest.

(b) Creation of a position of Vice-President (Learning and Teaching)

Council has created the position of Vice-President (Learning and Teaching), to take a proactive approach to lead the promotion of learning and teaching of mathematics, including research training, and be a senior spokesperson for learning and teaching of mathematics on behalf of the Society. It was decided that there should be a wide call for expressions of interest in the position.

(c) Society Teaching Excellence Awards

Council has established two annual Teaching Excellence Awards, each of \$1,000, one of which is to be restricted to early career teachers, including sessional teachers and PhD students. It is hoped that detailed guidelines for the nomination and selection process can be decided in time for awards to be made in 2018.

(d) Financial decisions

In addition to ongoing commitments, such as subventions to Divisions and Special Interest Groups and a subscription to AMSI, at its recent meeting Council approved over \$140,000 on specific items. Over \$80,000 was allocated for conferences and a further \$49,000 to be provided to individuals to support conference attendance. Other smaller amounts, totalling \$13,200, were allocated to prizes, the International Mathematical Olympiad, WIMSIG advocacy and representation at Science meets Parliament.

Proposed amendment to paragraph 67 of the constitution

December 2018

Paragraph 67 of the constitution governs the conduct of Society elections. It stipulates that "The ballot shall be sent by the Secretary to each Honorary, Ordinary or Sustaining Member of the Society". This arguably does not permit members to be directed to a website at which the ballot can be completed. The proposed amendment replaces "The ballot may be sent to the members" in 67(2) by "The ballot paper shall be made available to the members". To cover the situation where a ballot paper is not sent to members, the following additional stipulation is added to 67(1): "Notice of the ballot and instructions for voting shall be sent by the Secretary to each Honorary, Ordinary or Sustaining Member of the Society".

Current version of paragraph 67

- 67. (1) The ballot shall be sent by the Secretary to each Honorary, Ordinary or Sustaining Member of the Society at least thirty days before the ballot closes.
- (2) The ballot may be sent to the members by post, facsimile, electronic mail or by any other method of electronic transferral of information, as determined from time to time by the Council.
- (3) Each such ballot, provided it is completed in accordance with this Constitution, shall be valid if returned to the Secretary by post, facsimile, electronic mail or any other method of electronic transferral of information, as determined from time to time by the Council.

Proposed revision of paragraph 67

- 67(1) Notice of the ballot and instructions for voting shall be sent by the Secretary to each Honorary, Ordinary or Sustaining Member of the Society at least thirty days before the ballot closes.
- (2) The ballot paper shall be made available to the members by post, facsimile, electronic mail or by any other method of electronic transferral of information, as determined from time to time by the Council.
- (3) A ballot paper completed in accordance with the constitution shall be valid if returned to the Secretary by post, facsimile, electronic mail or any other method of electronic transferral of information, as determined from time to time by the Council.
